## **RULES FOR SANCTIONED DRESSAGE SHOW YEAR END AWARDS:**

Enrollment forms are due and must be post marked by November 15<sup>th</sup> of each award year.

Submit one Enrollment Form and \$15 enrollment fee per horse and rider combo, per award division.

Please submit three scores from three different judges at any one level from any approved TREA Sanctioned Dressage Schooling Shows. One dressage score may come from a USDF/USEF Recognized Show.

Eventing dressage scores are NOT admissible.

There is no minimum score to qualify.

Please include a copy of the front and back of dressage tests (total points and percentage must be visible) with judge's signature or a USDF computerized score sheet.

You must be a TREA member in good standing at the time the scores were earned.

Awards will be decided based on the highest combined average of the three dressage test scores.
